State Age Representative Selections for 2009 are being held on 10th August and 17th August 2008 from 9am to 2pm (maximum) depending upon the age group you are trialling for – some age groups may finish as early as 12 noon.

11s – must be born in 1998 – Court 25	14s – must be born in 1995 – Court 21
12s – must be born in 1997 – Court 30	15s – must be born in 1994 – Court 23
13s – must be born in 1996 – Court 29	

Under **NO** circumstances are you allowed to trial if you are not born in the above years.
PARENTS – Please read the back of this sheet with regard to attending the trials.

You are not allowed to wear any part of the Penrith District Netball Association Representative Uniform – this includes **SHORTS**. You are also not allowed to trial in **full** club uniform. If you are wearing any of the above items of clothing you will not be allowed to trial unless you change your clothing prior to selections starting.

Once selections start on the **FIRST DAY**:

1. You are **not allowed** to change the position you nominated for. *Please do not come to the selectors' table and state that you put down the wrong position AFTER selections have started, because you will not be allowed to change them.*
2. You are **not allowed** to leave the selection area unless you have notified the Representative Convenor.
3. Remember the number given to you on the first selection day. **DO NOT CHANGE NUMBERS WITH ANYBODY** – the number is the selectors' way of identifying you. If you receive a different number on the second week you are to notify the selectors IMMEDIATELY.

If you have any problem during the day, you are to see Mrs Tricia Mann, the Rep Convenor.

PARENTS - PLEASE NOTE

As per Penrith District Netball Association's Rep By-Laws, the following rules apply:

- 3.4 a) iv) For 11 Years Development Squads and State Age Championships, the player must be a current registered, playing member of the Association, except where Rep By-Law 3.4 d) applies.
- 3.4 b) Any player who registers to play, and plays in the next immediate Association Night Competition, shall be deemed eligible for State Age selection in accordance with Rep By-Law 3.4 d).
- 3.4 d) New players who provide proof of moving into the district may be accepted into a squad prior to the selection of the team of nine to 12.

INABILITY TO ATTEND SELECTIONS

- 2.15 a) No player will be considered for selection unless prior notification has been given to the Rep Convenor of special circumstances, eg injury/illness to be supported by a medical certificate, or if absent from the district (school camp, holidays) to be supported with appropriate documentation, except where application is made under Rep By-Law 3.4 d).
- 2.15 b) Where a player does not attend the selections, and that player believes that special or compassionate reasons prevented the player from attending, a written application may be made to the Executive Committee within 48 hours of team selections before teams are ratified. The reason(s) for non-attendance must be disclosed and include, where appropriate, relevant documentary evidence. The Executive Committee will decide if the player is permitted to be considered for selection.
